The November 2021 Liberty Music Boosters meeting was called to order by Rob Vendramin at 7:02 pm.

Administrative Updates

- Previous meeting minutes review/approve -Kelly sent via email on Monday, re-sent with attachment at time of the meeting.
 - Minutes approved and no corrections provided.

- Treasurer's Report – Roy and Jen-not present, sent report by email
 - invoice for the fall concession charges. Everything is billed at 50% of our sale price. Total is \$486.50.
 - FOL: \$3624 (doesn't reflect square fees)
 - One donation this past week was for \$1000!
 - Pies: We sold 207 pies. We make roughly \$5/pie so that's \$1035
 - Concessions: \$54,939 but COGs hit \$31,387. That's not great on profit for the season. COG is usually 50% higher, which adds to the need for raising the cost of items in Spring.
 - Board & Brush is Wednesday, 11/17. Only 15 booked.
 - Kroger donation was under for the quarter. We usually hit \$460 but it was closer to \$360. Might be a good idea to send out a reminder on how to sign up for that and also include Amazon smile. Holiday shopping might boost those numbers.

- Communications Report – Nadine- not present, sent update
 - Upcoming performances and yard sign info have been put in the extracurricular / Patriot Parent. If directors have any special recognitions to forward them to Nadine and she will put them in the extracurricular
 - Confirming yard sign proofs and will be off to print
 - Jill commented there has been more visibility with information put in the extracurricular

 - Absent, sent update

 - Winterline has 42 students signed up, HS has calendar of dates, middle school group is back up and running since not having last year dear to Covid

 - Had 2 successful concerts, split into 2 nights and it went well with support of each other
 - Concert on December 15, 8th graders will be invited to play, everyone will play
 - Service orchestra will play on thursday at nursing home and 1st time back since shut down due to Covid
 - Solon ensemble starting now, it is not until February, but music started now
 - Half of uniforms have arrived on time before concert
 - Doing performing tour of elementary schools
